The last Annual Meeting of your Council was held at the United Services Club, Brisbane, on Thursday 2nd May, 1963, at 10 a.m.

There has been no reason for a meeting to be held since that occasion.

It is deeply regretted to record the passing during the year of Mr. R. Horton Wallman, O.B.E., Ll.B. (South Australia), 11th December, 1963, Mr. Robert Lyndon, 26th July, 1963, Mr. Charles Stewart 27th July, 1963 (New South Wales) and Mr. Cliff Cullen 7th January, 1964 (Queensland).

Rex Wallman was South Australian delegate to your Council for over twenty years (1937-1958), and Chairman of the South Australian Rowing Association for over thirty years and a former President of the Australian Amateur Rowing Council. 1981.

Bob Lyndon gave a lifetime of service to rowing in Queensland and was the only member of that State holding a F.I.S.A. Judge/Umpire's Bob's last official rowing duties were to officiate at the Empire Games in Perth recently, unfortunately he was not able to see the last King's Cup in his home State in Brisbane but on that occasion oarsmen from throughout Australia visited Bob in hospital.

# PROPOSED NEW ZEALAND TOUR AUSTRALIA 1964

Much correspondence and conferences have taken place in an endeavour to satisfactorily arrange this tour. At the time of the writing of this report arrangements have been made for the New Zealand Eight and Sculler to compete in a test race in Victoria on the 11th of April in conjunction with the G.P.S. Regatta. However, there are still difficulties regarding the arrangement of test races in New South Wales for the Eight and the Sculler. It is sincerely hoped that these can be overcome and that the New South Wales Rowing Association will be successful in arranging a test race in conjunction with their G.P.S. Regatta on the 18th April and another test race with the New Zealand Eight at the National Championships Regatta in Canberra. It is practically certain that the small boats from New Zealand will compete at the Australian National Championship Regatta, in Canberra at the end of April and the 2nd of May, 1964.

On the 16th November last an inaugural meeting was held to organise the above association to control rowing on the new Burley Griffin Lake's Course. Over sixty oarsmen from many rowing associations in Australia who now live in Canberra attended the meeting and the A.A.R.C. are grateful to committeemen of the New South Wales Rowing Association, Sir Harold Alderson and Messrs. John Rook, Ossie Rosevear, Laurie Steptoe, Keith Cummins, Kevyn Webb and Bill Purcell who attended the meeting and gave valuable support and advice in the formation of the association. Chairman is Mr. R.J.M. Luker, Honorary Secretary, Mr.W.E. O'Brien. Both are old oarsmen; Mr. Luker having rowed with the Sydney University, whilst Mr. O'Brien is from the Essendon Club, Melbourne. Haberfield Club, Sydney, have already donated a racing four, only four years old which is a fine gesture and a good start for the new club.

# PROPOSED VISIT AUSTRALIA RATZEBURG UNIVERSITY EIGHT GERMANY

After some negotiations I have received a cable from Dusseldorf to the effect that the above Eight is interested in coming to Australia and New Zealand immediately after the Tokio Olympic Games. Correspondence is being entered into now to find out what the financial obligations would be to Australia. To date no reply has been received. This very important proposal would be discussed at the Annual Meeting of the A.A.R.C. this month.

It is felt that a visit to Australia by this world famous Eight would be one of the greatest benefits to our rowing, both to oarsmen, coaches and officials.
